The following information is provided to assist the reader to understand the accounting statement and/or the Annual Governance Statement

### 1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £ 500.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

2. Line 3 - income from book sales increased by £348 in 2022 (this money is ringfenced for use for community projects and cannot be used for Council Running costs or statutory duties).  
- Other income includes increased bank interest and sundry items (field rent/sale to residents of surplus jubilee coins at cost).

3. Line 6 - the figure entered in 2022 column was a typographical error reading £1,362 it has been correctly re-stated as £1,591. Although this created an arithmetic error the closing figure of £8,751 in year ending 31/3/22 was correct and has been brought forward to line 1 of the 31/3/23 accounting statement





My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 and guidance issued by the Auditor General for Wales.

### Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

- The Accounting Statement contains a non-material arithmetic error due to roundings. We recommend that the Council checks the arithmetic accuracy of the accounting statement and makes the necessary corrections before the accounts are approved.
