0824/08	<b>Local Member Update: None -</b> Cllr CJW had sent apologies. She had advised that Councillors contact her directly with any queries of issues.
0824/09	Community Matters.  (a) Windfarm – no updates in respect of Garn Fach  (b) Broken road sign BwlchySarnau – reported to PCC but not yet repaired.  (c) Community Book – damaged book sold by local resident £12 cash received to be banked.  (d) D-Day Commemoration update - approximately 40 people attended a service of remembrance and thanks giving held in the Church in Abbeycwmhir. The service, which brought together those of all faiths and none was taken by Rev Lance Sharpe (Church of Wales) and Pastor Phillip Lewis (Bwlch-y-Sarnau Baptist Chapel), with readings by community members. It was attended by representatives of the Royal British Legion including the Standard Bearer The service was followed by light refreshments at the Philips Hall – Councillors noted their thanks to the community members who had made and given cakes and snacks for the event.
0824/10	Member Discussions and items not on the agenda: It was agreed to contact Powys County Council to comment on the poor roadside grass cutting and also on the placement of temporary information and warning signs on roadsides. Both concerns related to the lack of care to ensure safe visibility for road users particularly at junctions where signs frequently obscured driver's vision of oncoming traffic.  It was noted that as the grass/hedges at these points had either not been recently cut or had not been trimmed back from road edges/curbs as far as in previous years signs were often placed very close the roadside. It was suggested that those placing temporary signs should be provided with strimmers to clear the area around the sign placing in order that signs can be sited not only to inform drivers but also to ensure their safety while doing so.  Cllrs noted that they understood that PCC highway costs were under constant consideration but that these should be reviewed in the light of weather conditions which may increase plant growth requiring more frequent cutting at pinch points for passing on rural lanes and at junctions. It was felt that because many places were overgrown road edges could not be easily seen resulting in vehicles going 'off road' to pass and as a result increasing the damage to the sides of roads.  A letter of welcome had been sent to by the Chairman to the organisers of the Enduro GB.
